Know that all PLoS articles are directly deposited and searchable in PubMed and PubMed Central and can be archived in your institutional repository.

Be knowledgeable of the importance of author copyrights. All PLoS authors sign the Creative Commons Attribution License (CCAL), which allows anyone to download, reuse, reprint, distribute, or copy articles in PLoS journals, as long as the original author and source are credited. <http://creativecommons.org/about/>
